

Frequently Asked Questions #1

How do SUD providers transition to the DMC-ODS Waiver for Residential, OS, IOS and OTP/NTP?

By treatment type for the DMC-ODS providers:

❖ **OTP/NTP:**

- OTP/NPT Providers will not get a new RU#
- The old OTP/NTP procedure codes will end June 30, 2018
- OTP/NTP Providers will begin using the new procedure codes effective July 1, 2018.
- OPT/NPT Providers will begin using new MAT procedure codes, that requires NDC information for Medi-Cal billing, on the DHCS 837 submission file. Currently we are asking Providers to enter the NDC information on a spreadsheet and to retain that information for future use– see attached *Provider Log of MAT Drug Services*.

❖ **Residential 3.1/3.5:**

- If the Provider is **NOT DMC certified;**
 - Continue to use the old RU# and old procedure codes.
- If the Provider **is DMC certified;**
 - Provider has **not received** the new DMC-RES RU# - continue using the old RU# with the old procedure codes.
 - Provider **has received** the new DMC-RES RU#, but **has not attended CG training** – use the new DMC- RES RU# and new procedure codes, maintain paper charts (CG fillable templates), and input new service codes directly into InSyst.
 - New clients get opened in new RU. Transition existing clients according to instructions in the Episode Closing & CalOMS Reporting Instructions document distributed at the 6/7/18 SUD Provider Meeting & available on SUD transition page website.
 - For clients who have not yet been opened in new RU, continue to provide services under old RU and old procedure codes.
 - Provider has received the new DMC-RES RU#, and **has attended CG** and InSyst training –
 - Begin using the new RU# and new procedure codes for new beneficiaries. New beneficiaries will be opened to the new RU# using CG to complete the new procedure codes. All residential admissions must follow the DMC ODS Residential Authorization process flow chart supported in a training session at BHCS on 6-21-18 (and can be found on the *Transition to the DMC-ODS* web page).

- Transition existing clients over a 3 month period by discharging from the old RU and opening an episode into the new RU per the Episode Closing & CalOMS Reporting Instructions document distributed at the 6/7/18 SUD Provider Meeting & available on *Transition to the DMC-ODS* webpage. **Clients should be transfer equally between over the 3 month period** (1/3 of client should be transitioned in July, 1/3 of client should be transitioned in August and 1/3 of client should be transitioned in September).
- For clients who have **not yet been opened in the new RU**, continue to provide services under old RU and old procedure codes.
- **Providers have up to 10/1/18 to transition old beneficiaries to the new DMS-RES RU# no later than that date.**

❖ **OS/IOS:**

- If the Provider is **NOT DMC certified** continue to use the old RU# and old procedure codes.
- If the Provider is **DMC certified**,
 - Provider **has not received** the new DMC-OS/IOS RU# - continue using the old RU# with the old procedure codes.
 - Provider **has received the new DMC-OS/IOS RU#, but has not attended CG training** – use the new DMC- ODS RU# and new procedure codes, maintain paper charts, and input new service codes directly into InSyst.
 - Provider has received the new DMS-OS/IOS RU#, and **has attended CG and InSyst training** –
 - Begin using the new RU# and new procedure codes for new beneficiaries. New beneficiaries will be opened in the new RU# using CG to complete the new procedure codes.
 - Transition existing clients over a 2 month period into new RU per the Episode Closing & CalOMS Reporting Instructions document distributed at the 6/7/18 SUD Provider Meeting & available on the *Transition to the DMC-ODS* webpage. Continue to provide services under old RU and old procedure codes for clients who have not yet been opened in new RU.
 - **Unless otherwise arranged with BHCS, providers have up to 9/1/18 to transition old beneficiaries to the new DMS-ODS RU#.**
