About the Course

This workshop focuses on improving participants' ability to (a) describe the history of diagnostic classification and reasons for changes over the decades, (b) use the many culture relevant features of the DSM-5 manual and avoid ethnic disparities in diagnosis, and (c) distinguish between syndromes that commonly are mistaken for one another. Sensitivity to differential diagnosis is important when working with clients of all ages, and generational differences in manifestations of symptoms will be addressed. Extensive use is made of case vignettes & exercises. Participants will be encouraged to verbally present examples from their own practice experience for discussion.

Course Time:

- Identify 5+ common diagnostic errors and how to avoid them.

- Identify 6+ common diagnostic errors that leading to those misdiagnoses
- Identify 2 distinctions between substance induced symptoms and primary symptoms that are not secondary to substance use
