HSP Levels of Care

Q5) Is it possible to qualify for Tier 3 without being certified for non-ambulatory beds, offering injection, or TAY-specific services, if offering more than one ADL?

A5) No, Tier 3 is only for two or more of the four categories. ADL activities only form one category.

Q6) Can clients who are developmentally similar to TAY, but older, be waived into the TAY category?

A6) No, as the TAY population is strictly defined by the State of California to be between the ages of 18 and 24.

Q7) Is there a level of service category that applies to clients with substance use issues?

A7) There is no specific category associated with clients with substance use issues. Individuals with substance use issues may require support with ADL/IADLs pending ACBH HSO approval.
