- **Section I. A. Intent** on page 3: update to Services and Services Areas Table:

The awarded Contractors shall offer one or more of the following modalities:

- Residential treatment for youth and for adults **with EDs as the primary diagnosis** (24-hour programs);<sup>2</sup>
- PHPs **with EDs as the primary diagnosis** (a minimum of six hours of treatment per day and are available five to seven days per week);
- IOPs with **EDs as the primary diagnosis** (a minimum of three hours of treatment per day and are available three to six days per week); and

<sup>1</sup> Specialized Services may include combinations of services such as multi-disciplinary team approaches, individual therapy, group therapy, family therapy, monitoring by a licensed dietician, and medication support with a licensed prescriber/ psychiatrist in an outpatient setting.

<sup>2</sup> Bidders must have a valid California Department of Social Services (CDSS) Community Care Group Home License to be considered for a Residential program contract.

## RFPQ No. 22-01

- Transitional Housing for clients while receiving **ED specific** PHP or IOP if distance from the provider to the clients' homes is prohibitive for attendance in services.
- Specialized ED services may include a combination of individual, family, group therapy services utilizing a multi-disciplinary approach via in person or telehealth.
- **Section I. C. Bidder Qualification Criteria** on page 5: update to Minimum Qualifications: Bidder qualification criteria include the following:
  1. Bidder must have at least one year of experience providing **Eating Disorder specific treatment services** to the priority population **for the service/s applying for**.
